## Dear Inspector Mills,

Thank you for your telephone call this afternoon, however I find that your message, that the proposed hearing of my complaint to RSKNPF Internal Affairs, has been adjourned until tomorrow, utterly bizarre.

How can this be so after my letter yesterday.?

I made a clear an appropriate request for adequate notice of a hearing, for very significant and pertinent reasons of submission of evidence.

I also find it most strange that this matter is being driven in a way, in which it appears, that there is a deliberate avoidance of the fact that the main perpetrator is Charles Smithen, and that in fact, he was the main focus of my complaint to the RSKNPF Internal Affairs. Is someone deliberately protecting him.? If so why.? Surely what matters is the truth and justice.

I am not prepared to be part of some sort of 'cover up' of the deeds of Charles Smithen. Such impropriety should not be swept "under the rug", it should be addressed and put right, for the sake of this great country.

It begins to appear that Morton, is being made a scapegoat, when in fact his misdeeds are minor compared to those of his boss, Charles Smithen.

I respectfully request that you respond in writing to my letter of yesterday afternoon, and also to the points that I made to you in our meeting of 11.00 am yesterday morning, (Tuesday 12th January 2016).

For the same reasons that I stated at the said meeting, and subsequently in writing, it is not appropriate for me to participate in a hearing tomorrow, where the full facts are not on the table, and the relevant parties are not present. I can not be part of such false action.

In paragraph 68 of my Affidavit which was filed in the High Court on 30th October 2015, (copy attached
